Hi amazing aware Aussie Legends

Please find below our latest C&D Project update. I'm pleased to share that since our last update, our numbers have grown to 85 participants and we have now served 90 venues since we started at the end of July. 53 served in NSW, 24 served in SA, 7 served in QLD, 5 served in VIC and 1 served in TAS. We have also recently sent the documents to interested people in Florida USA, UK and NZ and hopefully they will get active with the C&D project in their countries too.





To ensure our action group is effective serving a C&D Notice to all Vaccination venues, it would be fantastic if everyone could aim to visit at least one different venue next week. By doing this we can double our reach to share the truth and simultaneously awaken those harming.

We are also urgently focused on quietly and quickly growing our participant numbers so please share the C&D Project and our progress so far discreetly with friends or family. You may be surprised how many others are now awake and want to do something, many just don't know what to do. This ensures that they will get all the progress updates too. It is certainly uplifting to receive details of venues that have been served and they should now be realizing that their health may have been effected and they are committing crimes against humanity.

Please remember when undertaking action in the C&D Project to be empathetic! Many staff vaccinating are totally unaware of the risk or damage being caused by the mrna platform/gene editing products they are administering. We were ALL lied to and the staff we are addressing with this action, were probably coerced to take it and many have encouraged their family and friends to take it too.

The mnra gene therapy is not safe or effective = zero benefits & a huge list of adverse events!

For anyone new to the project and/or those still unsure about what to say & how to say it, check out the Helpful Tips & Verbal Scripts section that will make it easier for anyone to get started.

Many hands will make light work of this task, shining a light on the truth so staff holding the syringe are made aware of the harm they are causing.

Please confirm via email, your suburb and state, if you have not done this already, I need this info ASAP, as I'm almost finished a new map of all C&D Project participants locations around Australia. I believe it will be helpful for us all to know where we are from, and where we need more participants.

Helpful Tips - for C&D Notice delivery.

- 1. Dress businesslike/professional, carry a folder, for the C&D notice, tracking sheet and a pen. Displaying a calm, confident, empathetic yet serious attitude will assist you greatly. Dressing in professional attire, will have the vaccinating staff assuming you are paid staff of an organization, instead of a volunteer from the public, and I find it boosts my confidence too!
- **2.** Fill in all venue details on the tracking sheet before I go in or after I come out, leaving only the name to be added when you are talking to the staff.
- **3.** Park away from the venues cameras (if you can), but not too far, so you can make a calm but prompt exit once you have finished delivering the information.
- **4.** Ask them for their name initially, and then just stick to the script and leave very little pause in what you say. They will be unlikely to even get a chance or think to ask your name, before you walk out. I believe it's best to keep your identity private in this very important work.
- 5. If possible speak to 2 different people, first aim for someone less senior to find out if they are doing vaccinations and also find out the name of the person you should speak to about it. Provide all the info and documents to the most relevant person jabbing.
 (It's an easier conversation if the senior person isn't aware you already put their name on a register.)
- 6. Remember to be flexible and empathetic with the conversation as you may not always be able to stick to the script. Also be aware that if you want to maintain control over the conversation, don't leave large pauses in your script, where they can interrupt and then flip the script or avoid your info and questions.

1. Do you think we should share our email addresses with each other so we are able to make contact with other participants to team up to approach the action in this project as a team ??

Most Popular answer: Yes with limits (emails shared only if requested and ok'ed by all those relevant)

If you want to work with others in your area, just email a request and I'll get in touch with relevant participants to get permission to share their email details. S.

2. Do you think it would be helpful to have a compiled document of links or whistleblowers names, to also share with those vaccinating to fast track their re-education??

Most Popular Answer: Yes – a list of facts other than vaccination issues should and could be created with input from participants to further wake the unaware vaccinators up.

3. Can you share the script that worked best or was most comfortable for you to say??

A handful of scripts were sent in, by participants who are safely completing this task with confidence, while still showing empathy and these are now fused into one script that anyone can use (see below).

We have created Helpful Tips & Verbal Scripts, which has been compiled from scripts sent in by participants. Feel free to use as is, or vary to suit your own personal style. S.

Consider these 3 points to stay optimistic & focused on the best result possible.

- 1. Once vaccinating staff are informed of the facts, they should not be comfortable to dispense any jabs ever.
- 2. Once patients are told of the thousands of risks and zero benefits, they should not be comfortable to give informed consent to be jabbed or to take any kind of jab ever.
- 3. Once vaccinating staff (knowingly harming people for financial gain), are told of their personal liability risk, (ie: no proper informed consent gained) they may not want to dispense any jabs ever in-case they are sued.

They are not paid enough to intentionally kill or harm others?!

Verbal Script - use as is or personalize to best suit you.

Walk into the pharmacy folder in hand, wait for their attention then ask politely "Hello Are you giving covid 19 injections or flu shots here?"

If they answer "Yes we are" then ask "Who can I speak to about this today?" (Write the relevant persons first and last name down on tracking sheet) then ask them "Can I please speak to them now as I have a very important document to give them?".

While waiting for them to go and find the relevant person, put away the tracking sheet with their name written on and get out the Cease and Desist notice, ready to give to the relevant person. Once the relevant senior person, is in front of you, hand them the cease and desist notice and say

"This is a cease and desist notice regarding the experimental mnra gene therapy which is causing mass death and disease. Please ensure you, and all other vaccinating staff, read this important document which details issues with the product. You must now cease administering any vaccines containing the Mnra gene therapy, including the flu shot, that is causing massive harm and a huge increase in disease and excess deaths."

Extra narrative to use if needed:

"You and this venue have been added to a registry of those dispensing the Experimental Gene Therapy."

"If you are seeking informed consent from all patients - you need to know that you are unable to get proper informed consent without fully explaining all the thousands of adverse effects."

"To avoid personal liability issues, you must first gain proper informed consent."

Walk calmly out of the venue leaving them to read and consider the serious info you have shared.

ASAP after serving a venue, or a handful of venues, email the data back for map inclusion.

To help awaken those who haven't yet seen the truth don't forget it's easy to use and share the three posters, and/or flyers created by printing in colour on a home computer, library or officeworks.

*** To use online, please email a request for a jpg version of the artwork that you will be able to upload online.

1. Informed Consent - Red Flags Flyer/Poster.

Print and give out as a flyer to inform anyone about the procedure required to get or give informed consent. Informed consent is not possible unless you have been informed of ALL risks. This can be shown to friends & family coerced into injection. If they thought they did give informed consent, and they haven't heard about the risks, they couldn't have given informed consent.

2. Adverse Effects Flyer - showing all risks from Pfizer document.

Print as single sided A3 Poster, or a double sided A4 flyer to hand out in a simply shocking yet informative way to show the risks of taking it with highlights on some of the worst adverse events.


3. No Informed Consent Poster/Flyer.
